9:02 AM A Conditional Use Permit to Allow Processing of Agriculture Products That Are Not Produced or Grown On-Site

Acting Planning and Building Director Nicole Stickney introduced the background of this Conditional Use Permit.

The project site is on parcel 109-470-048 at the southeast corner of the intersection of Coyan Road and Moon Road. The property is zoned AP-20 and the Comprehensive Plan designation is Agricultural. The applicant's proposal includes buildings for a farm shop, cleaning facility for farm crops, farm storage, warehousing, farm equipment storage and an office. Under the proposal, the new buildings would be added and leased to L&H Seeds. The seed processing mill will include an attached dust filtration system and the cleaning facility will operate twelve to twenty hours per day, depending on the season. The County Building and Planning Department processed the application, coordinated for agency comments, and reviewed the application in accordance with Chapter 17.82 Franklin County Code.

Franklin County has been working for several years with a number of regional jurisdictions to establish a consolidated emergency dispatch and communications center. This Interlocal agreement will establish the financial and legal obligations of Franklin County to buy-in to membership in BCES and be a voting member participating in the management of the consolidated entity.
