## Call to Order and Pledge of Allegiance

Commission Chairman Robert Koch called the Franklin County Commissioners' Regular Board Meeting and Public Hearing to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

# 9:01 a.m. Public Hearing Regarding Emergency Interim Ordinance 03-2019 Industrial Hemp

Planning and Building Director Derrick Braaten gave a background pertaining to the Interim Ordinance 03-2019 regarding hemp production. Congress passed the 2014 Farm Bill, which included an allowance for states to start hemp production pilot programs, and for such activity to be considered "farming". In 2016, Washington State began pilot programs, through the WA Dept. of Agriculture (WSDA) for research purposes. Congress passed the Agriculture Improvement Act of 2018, allowing for states to commercially produce, process, transport, and sell hemp or industrial hemp. On April 25, 2019, the WA State Legislature passed E2SSB 5276, which the Governor signed on April 26, 2019, going into effect immediately. However, neither the USDA nor the WSDA have created final rules for the industry, as directed by E2SSB 5276. In response to this action, on May 14, 2019, Franklin County adopted Ordinance 02-2019, establishing an up to six (6) month moratorium on the siting, licensing, production, processing, and sales of "hemp" or "industrial hemp", to allow for County staff to research the issue and determine how to best accommodate this new crop commodity.

After the moratorium was established, Staff researched potential and known impacts from such activities, the current regulatory and licensing process, and Franklin County Code. The results of that investigation are the basis of the new FCC Chapter 5.14, adopted on May 28, 2019. Due to Ordinance 03-2019 being an emergency interim ordinance, a public hearing must be held before the body enacting said ordinance.

Planning and Building Department recommends Maintain Interim Chapter 5.14, Hemp and Industrial Hemp Production, Processing, Transport, and Sales, as adopted on May 28, 2019, through Ordinance 03-2019, until such time as final rules regarding hemp related activities are adopted by the Washington State and the United States Departments of Agriculture.



9:07 a.m. Commissioner Koch opened the Public Hearing for comments to hear testimony for or against the Interim Hemp 03-2019 Ordinance. No comment from the public.

Commissioner Peck weighed in with his concern that the State was giving unfair advantage to some growers, due to how the Industrial Hemp Program was brought forth.

Commissioner Koch closed the public hearing at 9:15a.m. Planning and Building Director Derrick Braaten sought a consensus from the Board to go forward with the existing ordinance. The decision was unanimous.

#### 9:21 a.m. Administration Office Business

- Administrator Keith Johnson proposed a letter drafted by Commissioner Didier regarding the lack of agriculture\farmers on restoration and enhancement committees and additional wastewater fees imposed on wineries.
  - It is in Franklin County's best interest to extend an invitation to all Eastern Washington Counties to support this letter, as all Eastern counties have a stake in the matter.
- Mr. Johnson sought consensus on holding an evening Commissioners' meeting. The next evening meeting will be August 27, 2019 at 7 p.m.
- Commissioner Koch mentioned that the Washington State Department of Transportation (WSDOT) started working along 395 and cross roads.

- Public Works Director Matt Mahoney weighed in on the county roads and repairs.
  He stated it is very difficult to achieve the desired goal of 100 miles of road maintenance, when finances limit it to 40-45 miles. State and Federal money is dwindling as well, which makes it even harder.
- Commissioner Peck brought up the reality of a road shift, sustaining the functions of the county in the future and what it would be facing it were not accessible.
