#### Call to Order and Pledge of Allegiance

Commission Chairman Robert Koch called the Franklin County Commissioners' Regular Board Meeting to order at 9:00 a.m., in the Commissioners' Meeting Room in the Franklin County Courthouse located at 1016 North Fourth Avenue, Pasco, Washington.

#### 9:01 a.m. 2020 Census Outreach Information

Dr. LoAnn Ayers presented the Board with data from the 2010 census, beginning with a 31% turn out, which limited funds available for various programs. Dr. Ayers noted that the federal government covers \$2300 per person per year for programs and with a low turnout; it effects the census driven dollars in a severely negative way.

Dr. Ayers is reaching out to all employees and the public, to encourage citizens to complete the census and give families correct information. She admonishes people to be aware of those who are not from the census bureau. The Census workers will never call or email you. If someone asks you for your social security number, beware, as it is fraud. You will receive a letter in the mail or you may go to the website for help at 2020census.gov.

#### 9:15 a.m. WSU Extension - Food and Nutrition Update

Associate Professor, Food & Nutrition Specialist Lizann Powers-Hammond presented an update on WSU Extensions' Food and Nutrition Program. There are different entities that work in the Food Safety area, such as the Department of Agriculture, Health Departments and WSU Extension. While the WSU food program is educational, the other two are regulatory.

WSU Master Food Preserver Volunteers have spent 1,148 hours of outreach education thus far in 2019. Served approximately 4,400 contacts.

She handed out papers related to canning safe pie filling, making fresh cheese, and prevention of food poisoning and economic cost of food borne illnesses.
