7:08 a.m. Public Comment

- Jeffery Robinson was concerned legality of meeting without safety protocols. He believed the statement made, "Latinos are unmotivated to vote" during a previous meeting, was racist. He thought the Commissioner should apologize.
- Lawanda Hatch was in the meeting, which spoke of unmotivated voters and clarified that
 the Commissioners opinion was that instead of bringing lawsuits upon the county, the
 plaintiffs should be working harder to get the Latinos registered to vote. She asked that
 there be no political expediency on the backs of the community.

- Citizen assured the Commissioners that calling someone unmotivated is not the most racist thing you can say.
- Patti Bailie voiced her concerns on the Assessors letter seemed threatening. She suggested changing the verbiage.
- George Dockstader concerned with the Commissioners that have held positions on the Ben Franklin Transit and complain about the tax that could be used for Mental Health issues. He suggested they run a campaign and do something about it.

7:18 p.m. OPEN PUBLIC HEARING Redistricting Map

* Commissioner Didier opened the open public hearing at 7:18 p.m.

Commissioner Peck explained his position of choosing map #3 in the last meeting, however, seeing no movement in the other Commissioners to choose a different map, he compromised and went with map #2 in order to comply with the obligation in proposing a map.

He will accept map #1 or #3. However, he chooses map #3 and will stay there.

Commissioner Mullen asked for the demographer's recommendation. Administrator Keith Johnson said the demographer did not give a recommendation at this time. Commissioner Mullen voiced his opinion that map #2 is the only one that does not lean towards the packing and cracking term.

Commissioner Didier asked Administrator Keith Johnson if he knew of the percentages of each map, and when he had knowledge of such data. Mr. Johnson replied that he had some data that was given to the committee; however, the latest data was given to him yesterday and he shared it with Commissioner Mullen, since he asked for it. Commissioner Didier wanted to know why this information was not given to him, as this would have made a difference in the map of his choosing. He was concerned that he had not been given this data to make an informed decision. Had he known that map # 4 was 86% Latino, (considered packing), he would have never voted for map #4.

Commissioner Didier asked Commissioner Mullen to read the data he received on the percentages of each map.

#1=81.1% #2=67.8% #3=80.5% #4=79.4% #5=73.3% #6=80.8%

Commissioner Peck said the numbers are not based on eligible voting age and until we have those demographic numbers, these numbers listed are of no help in distinguishing cracking and packing.

Prosecuting Attorney Shawn Sant explained that the Demographer was made available to the Redistricting Committee for any questions they might have. He spoke of the December 31, 2021 deadline for the Commissioners to choose a proposed map. The Commissioners then have the opportunity to tweak the map as needed based on public opinion and demographer input.

- Jeffery Robinson voiced his opinion that map#1 or map#3 are the only ones that could possibly pass in court. He was concerned with the lack of transparency.
- George Dockstader said the Committee worked their tails off on behalf of the county and held meetings for the community to attend. The meetings were transparent and if people did not show up for the meetings, it was on them, do not complain.
- Lawanda Hatch asked how the maps could be proposed without the demographer's numbers.
 Someone is not doing their job, because every Commissioner should have had the numbers for each map given to them last week. She thanked the Redistricting Committee for their hard work and time that they put into this process.
- Kurt Didier said if the data goes strictly on voting Latino only, then none of the maps will satisfy the courts. It would be an even bigger disadvantage to them if the county chose district only.
- Dave Cortinas has followed the Yakima lawsuit and others. He does not support any of the maps and believes they are all out of compliance.
- Citizen thanked the Committee and Commissioners for taking this redistricting seriously and standing up for our county.
- Steven Bauman has attended every meeting and does not understand how we have gotten to
 this point and the maps do not comply. He was concerned that three Commissioners all have
 different information on this subject. The Commissioners are in charge and need to get the
 information from those who have the information.
- Administrator Keith Johnson read a letter on behalf of Felix Vargas, who was on the redistricting committee. He opposes Map#2 that the Commissioners voted on in December.
- Lupe Cardenas was part of the Redistricting Committee and worked hard to come up with a
 map with the demographer. Map #2 fits more with what the demographer recommended. He
 was surprised that the Commissioners were not given the information the committee had on
 data. Everyone has an equal right to vote.
- Ms. Pamela thanked the Committee and was concerned that the Commissioners chose the similar map to what exists currently. Pasco deserves more than one Commissioner. She read the definition of racism. She does not like her tax dollars spent this way.

- Commissioner Peck clarified state and federal laws, as well as cracking and packing.
- Lupe Cardenas suggested following the demographers recommendation.
- Lawanda Hatch appreciated the clarification. There are four representatives in the city of Pasco. The city of Mesa and city of Connell have a majority of Latino voters. She supports Map #2 as it keeps all of the voting Latinos together.
- Jeffery Robinson is not concerned about the politics he is concerned with following the law.
- Dave Cortinas suggested proposing a fair map.
- Kevin Heinen concerned about why each Commissioner is not getting the same information. He stated that the Commissioners are not racist nor is Franklin County.
- Jake Dorsey suggested using Nation Builder, which is an app that can use demographic data for campaigns.
- Steve Simmons suggested that having the information from the demographer is extremely crucial to make a decision on maps. By using the demographer, the Commissioners can make an informed decision on a map that complies with the laws.
- Leo Peralez assisted with City of Pasco and the ACLU. There seems to be a lack of
 information to make a determination, from what he has observed from this meeting. He
 believes in a collaborative approach and rid the decisiveness.
- * Commissioner Didier left the Public Hearing open to continue to the next meeting.

Commissioner Didier wished everyone a happy new year.
