- George Dockstader asked why Franklin County is with Greater Columbia Behavior Health and not a Benton -Franklin entity.



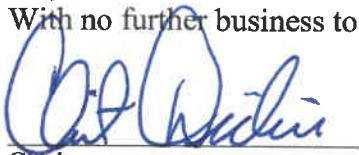

- Commissioner Peck explained that GCBH is a limited liability company formed under state direction and guidelines. It is funded with state dollars. The local proposed KGH is funded by the .01 mental health tax. The authorities and funding are different, however, the population intended to be served is not different.
- Steve Bauman asked if Keith Johnson would explain the program and would the county be able to pull out of the GCBH group?
Mr. Johnson and Commissioner Peck explained the process as much as possible.
- Sheriff Raymond stated that the community would like to have a one-stop shop. He asked how are the private entities able to fit in to the program. Initially the program will not receive state funding; however, once you create a one-stop shop, you can then ask for state tax dollars.
- Steve Bauman asked about the nine county model. Mr. Johnson stated that the state divides the areas into sections.
- Assessor John Rosenau spoke of HB 1782 that is coming before the House Rules Committee, which he is opposes. Creating additional middle housing near transit and in areas traditionally dedicated to single-family detached housing.
