Mr. Floyd spoke of the redistricting settlement agreement and reasons he believed it was in the best interest of the citizens of the county.

- 1. Franklin County gets to keep the map that they chose, which complies with current Washington Voting Rights laws.
- 2. Plaintiffs have \$1,420,000.00 in attorney's fees. Under statue, they are entitled to recover their attorney's fees. By negotiating settlement, Mr. Floyd was able to reduce this amount to \$375,000.00 with installments.
- 3. Franklin County will be able to keep its existing election system.
- 4. The County will be immunized from any further lawsuit, by any entity, regarding voting rights act for the next four years.
- 5. Nothing in this lawsuit is about being racist. That statement is mischaracterized. This lawsuit merely indicated it had racially polarized voting, which is the result of democrats versus republicans.
