Commissioner Didier thanked the Firefighters and EMS (Emergency Medical Services) for their services.

Interim Administrator Duane A. Davidson spoke a few words on the purpose of the meeting and introduced Shirley Jones who is administering the ARPA funds.

Mr. Davidson then turned the time over to Connell Fire Chief Ken Woffenden. Chief Woffenden has been working with 9th District Representative Joe Schmick and Senator Mark Schoesler to help with the added expenses required to service Coyote Ridge Corrections Center and Palouse Falls State Park.

Pasco Fire Chief District 3 Mike Harris gave some statistics on EMS and levies in the state of Washington. He made a spreadsheet of just one model type in order to show some way to move forward in solving the lack of Emergency Services in Franklin County. He explained that there are many different avenues to achieve success; this was just a starting suggestion with the limited time he had to put this presentation together.

City of Pasco Fire Chief Bob Gear spoke about his department helping the other surrounding fire districts and the support they want to give in assisting the other departments in obtaining funds they need for emergency services in the county.

Fire District 4 Chief Steve Cooper spoke of his all-volunteer district and without the help received from District 3 and the City of Pasco their district would be hurting.
